
Thanks to Kathy for doing a great job of organizing the trials.

# Godfather Style Dog Training

I love the AMC Channel.

Why?

Because they show all my favorite movies. This month, they have been showing one of my all time favorites, "The Godfather."

As I was sitting there chomping on some popcorn, I was struck with a thought as Marlon Brando uttered the now famous line, "I'm gonna make him an offer he can't refuse."

You see, dog training is the same. In order to get training results, you need to make your dog an offer he can't refuse. I'm NOT talking about the kind of motivation that Don Corleone and Luca Brasi use. They use negative motivation to get results.

Instead of using violence and anger, you want to find ways to positively motivate your dog. A point that I always stress when I am teaching someone how to train his or her dog is this: Training does not happen without motivation. You need to motivate your dog if you want her to perform. I also stress the fact that there are two forms of motivation: Positive and Negative. Both forms of motivation can produce results.

For a long time, dog trainers would not use food or other forms of positive motivation because they had

the silly notion that a dog is supposed to work for its master, PERIOD.

So dog trainers of the past would put a choke chain on the dog and use negative motivation to get the dog to comply with the command. The pain motivated the dog. In order to escape the pain, the dog would comply. This was a very bad way to train.

Whenever a trainer uses negative motivation, he will get side effects. A killer whale trainer once said: If you put a shock collar on a killer whale, you will have a very short training session because there is a good chance that the whale will eat you when you get in the pool.

He went on to say that aggression is caused by negative training methods. I completely agree with him. You can't constantly expose your dog to negative training sessions and not expect it to produce negative side effects.

At this point, many dog owners think that if you use food to train, the dog will only work for food.

Using food is only one part of the training process. Once your dog starts to learn a command, you can start to use life rewards.

A life reward is anything that the dog likes or wants. Does your dog like to go for car rides? Before you open the door and let your dog in, give your dog a command - sit, down, stay, etc.

Compliance is what we want from our dogs when we are doing obedience. You get compliance by motivating your dog.

Here is the secret of compliance:

- 1. Ask
- 2. Motivate
- 3. Reward

Through repetition, your dog will start to learn the command.

<u>Conclusion</u> - In the movie "The Godfather," negative motivation was used to get compliance, something we don't want to do when we are training our dogs. Instead, we want to use positive motivation. By using positive motivation, we don't have to resort to aggressive training techniques that promote aggression in dogs.

### #1 All Time Dangerous Breed

The #1 most dangerous breed are **media outlets** that deliberately breed fear, spreading myths and lies about dog breeds and canine behavior through irresponsible reporting and reinforcement of undeserved and negative breed stereotypes.

What You Can Do About It:

- Call up the paper, the TV station or email the website and complain about the biased dog story
- Ask for the Editor, Sales Manager and/or Program Director.
- Tell them you won't read, watch or visit.
- Tell then you won't patronize their advertisers until they stop their biased coverage.
- Tell them they have the opportunity to spread knowledge, not fear.
- Tell them "My Dog Votes!"

GOAG Agility Fun Matches at the NHS meadow. The matches will be on August 28<sup>th</sup> and September 18<sup>th</sup>. Fee is \$6.00 for the first and 2<sup>nd</sup> run or \$15.00 for as many runs as you wish. Matches start at 5:00 and go until dusk.

### How To Remove Ticks From Pets

Ticks thrive in woody, grassy and brushy areas and carry diseases such as Rocky Mountain spotted fever and Lyme disease. That's why it's essential to keep them off your pet. Here are a few steps to ensure your pet is tick free.

Instructions

**Step One**: Check your pet for ticks daily if he spends a lot of time outdoors, especially if you live in an area known for ticks.

**Step Two**: Put on latex gloves to avoid direct contact with the tick and contaminated skin, as diseases can be transmitted from tick to pet to human.

**Step Three**: Feel your pet all over, especially around the neck, head and ears. If you encounter a lump like a small pea, move the fur on your pet to see if you have found a tick.

**Step Four:** Look to see if a tick is protruding from the skin. Ticks are tiny black, brown, reddish or tan disklike arachnids (having eight legs), about the size of the head of a pin. If they have attached themselves to their host (your pet), then they can swell up to the size of a grape in some cases.

**Step Five**: Put your pet in a comfortable position. Ask a friend or family member for help in distracting your pet.

**Step Six:** Grasp the tick with tweezers as close to your pet's skin as possible; make sure not to pinch your pet's skin.

**Step Seven**: Pull the tick out using a straight, steady pulling motion. Be gentle; pulling too hard on the tick can cause its head to remain lodged in your pet's skin, which can lead to inflammation and secondary infection.

**Step Eight**: Dispose of the tick by throwing it into a fire, or by squishing it in a tissue using the tweezers and then flushing it down the toilet. Do not smash it with your foot or your bare hands.

Step Nine: Apply antiseptic ointment to the bite.

**Step Ten**: Remove and wash the gloves, and wash your hands thoroughly.

**Step Eleven**: Clean the tweezers with hot water or isopropyl alcohol or by holding them over a flame.

# Carol Wilson Honored

The Carol M. Wilson Endowed Chair in Nursing has been established at the University of Nebraska Medical Center College of Nursing through the University of Nebraska Foundation.

Carol was the longtime director of nursing at the former University Hospital, now part of the Nebraska Medical Center. She served nearly 40 years in the role then later in her career as assistant director for health services administration. She retired in 1992. and passed away in 2007 at the age of 82.

She was a volunteer for the University of Nebraska Medical Center College of Nursing.

The endowment is one of six endowed chairs and professorships at the college.

"The chair will focus on her passion -- improving health systems -- and enable the college to add a first-rate nursing scholar to the faculty," said Virginia Tilden, dean of the UNMC College of Nursing.

Carol was a valued member of BDOC for many years and served as president of our club as well as holding other positions supporting dog obedience.

Will Beg For Food By Cesar Millan

Begging is one of the most common issues that dog owners face. An unfortunate side effect of loving our dogs so much is that we would like to give them everything that they want. So when they start begging, it's almost too much for us to bear... and we cave! With a little willpower on your part, though, begging can be one of the easiest behaviors to correct. Follow these simple tips to turn your hairy panhandler into a productive member of society once more!

 DO NOT GIVE FOOD. This tip may seem like common sense, but you'd be surprised how few people consider it when they're looking into the wide, wet eyes of their beloved canine companion. That high-pitched whine is an effective tool against you, and your dog knows it. Why? Because it's worked before! Giving food is a form of affection, and giving affection reinforces the behavior preceding it. Your dog has learned that if he begs, he gets food! Take a stand and start a new trend. Find the willpower to withhold that food, and your dog will learn that he can't expect rewards for begging behavior.

- IGNORE. Begging is an attention-seeking behavior. Rather than give in to your dog's demands, ignore the behavior and teach your dog that it does not get results! When you talk to your dog, give him affection, or engage in direct eye contact, you are feeding his mental state. Instead, practice no touch, no talk, no eye contact.
- 3. DON'T FEEL SORRY FOR YOUR DOG. Your dog is well-fed. You should know; you feed him! He is not in danger of going hungry if you don't give him that scrap off the table, so don't feel sorry for him when he flashes you those doughy eyes and places a single paw forlornly on your leg. If you become concerned about how much your dog should be fed, talk to your veterinarian. This can help ease your concerns and allow you to remain calm and assertive!
- 4. BE CONSISTENT. In any kind of training, consistency is the key to success. For your dog to learn that his begging behavior is ineffective, it has to be ineffective 100% of the time. Inconsistent enforcement of the rules leads to an inconsistently obedient dog! Make sure that every pack leader in the household understands and enforces the same rules.
- BE PATIENT. Few dogs change overnight. If you have followed these tips to the letter and your dog continues to beg, don't despair! See Tip #4. Stay consistent and don't give up. Your reward will be a better behaved dog!

# Palladia New Anti-Cancer Drug for Dogs Wednesday June 3, 2009

The Food & Drug Administration (FDA) announced it has approved the first canine cancer therapy in the US. The drug is called Palladia<sup>tm</sup> (toceranib phosphate) and it is used for treatment of (MCT) in dogs.

"In the weeks and months ahead, Pfizer will introduce Palladia to boarded specialists to expand the body of clinical experience with this new therapy. The experience gained during this time will enable us to support veterinarians more effectively when we make the product available for purchase in early 2010," said George Fennell, vice president, Companion Animal Division, Pfizer Animal Health. Mast cells are produced in the bone marrow and found in connective tissues. They are part of the immune system and release histamine in response to parasites, allergens or trauma. (For example, squeezing this type of tumor can cause it to enlarge in size.) Mast cell tumors are a common *skin tumor* in dogs and cats, but can be found anywhere in the body. Clinical appearance can vary greatly: raised, hairless, soft, firm, ulcerated, etc., so a fine needle aspirate or biopsy is required for positive diagnosis. A tissue biopsy is needed to stage (grade) the tumor. Because of the unpredictable nature of this tumor, malignancy is usually assumed until proven otherwise. Wide margins must be obtained when removing these tumors. Lymph nodes and spleen should also be evaluated. MCTs are classified as Grade I, II or III. Grade III is the most severe. Between 7 and 21% of all canine skin tumors are mast cell tumors.<sup>1</sup>

According to the <u>Morris Animal Foundation</u>, 1 in 4 dogs die of cancer. News of this new treatment is encouraging for this common and potentially serious form of cancer. Hopefully this will open the doors for additional anti-cancer therapies in the near future.
