#### Peanutbutter Cups

INGREDIENTS

→30 ounces plain or vanilla yogurt (I like to use plain natural yogurt.)

 $\rightarrow$ 1 cup of peanut butter (We use a natural variety without additives!)

#### **DIRECTIONS**

→Step 1: Melt your peanut butter in a microwave safe bowl - 20 seconds does the trick!

→Step 2: Combine the yogurt and melted peanut butter, stir until well blended.

#### Sport Dogs

I'm often asked what it is like to own and compete with sport dogs, to which I reply, "It can be a challenge, and is often a lot of work, but it is also a lot of fun and hardly seems like work to me." In my opinion, living with a sport dog is a lifestyle. Similar to having a child who is involved in many after-school activities and sports, you can imagine the time commitment and discipline required. These activities can be very rewarding when your loved one succeeds.

Not to get confused with the class of breed known as sporting dogs, a **sports dog** is a dog that competes in dog-related sports. All breeds of dogs can compete in a variety of dog sports, some may be better than others but for the most part, with proper training and a balanced diet, you too can have your dog compete in a sport such as Flyball or Dock Jumping. Dogs best suited for competition already enjoy living an active lifestyle, respond well to being around people and are highly trainable.

The following tips would be useful for anyone who is thinking of signing their pet up for an organized dog sport or multiple sports. Firstly, you will want to start with conditioning your pet. This could mean playing Frisbee at the park, or perhaps going for a run around the block. Not only will your pet benefit from the fresh air and exercise, but you as the owner can also benefit from this healthy choice and use it towards further engaging in a healthy lifestyle while bonding with your pet at the same time.

It might already seem obvious to you, but generally athletic people own or train sport dogs that share in a similar lifestyle as them. Ever heard of the saying, 'Like father, like son'? Well that is the case here; in order to participate in these events and succeed, a certain level of fitness is crucial. Speaking from personal experience, a good diet, active lifestyle and training are everything you need to be successful.

When competing, I would recommend you start with building a strong training foundation for your dog. This not only means training your dog physically, but also preparing them mentally for what's to be expected leading up to and during a dog sport competition. Depending on the sport, please make sure to offer your dog the proper training as necessary and then customize their exercise routine and diet accordingly. Consult with your Veterinarian, and they can put together a nutrition plan for you to have your pet follow and can suggest supplements or vitamins for them to take to help maintain a healthy and active lifestyle.

If you are part of a training club like I am, they might offer "fun days" where you and your dog can try out new sports in a safe environment. This allows you to learn the rules of the game and what it takes to compete. Don't be overwhelmed, thinking that it's too much of a chore to have your dog compete in dog sports. Like I said before, it can be a lot of work but can also be very rewarding. If you're an athletic and competitive person like I am, than you'll have loads of fun!

Any training that you do with your dog will lead to a happy, healthier and better behaved dog. No matter how bad your day is, a quick play or training session with your dog can only make things better and I guarantee it will bring a smile to your face. Remember, sports are supposed to be fun, so get out there and get active!

#### Dog Training is Simple - Keep it that Way! Connie Cleveland

As an obedience enthusiast, you are a behavior modifier - constantly modifying the behavior of your canine partner. We are on the cusp of a culture that makes dog training far more complicated than it needs to be. For the next several posts, I'm going to give you some rules to use to keep training simple. Try employing them and see if what you thought was complex becomes remarkably simpler.

#### **Stop Using "To Be" to Describe Your Dog** Do not describe your dog using the word "is." For example, "My dog is shy," "My dog is soft," "My dog is scared," or "My dog is aggressive." When you use a form of the verb "to be" to describe your dog, you are

stating that his personality is unchangeable. Instead, use the verb "to act."

Using the verb, to act, changes the statements to, "My dog acts shy," "My dog acts soft," "My dog acts scared," and "My dog acts aggressively." When you use the verb "to act" instead of the verb "to be", you will see the behavior as something you can change.

Better yet, use the verb "to act" in the present tense. "My dog is acting shy," infers that it is a temporary and current condition, but you intend to change it. "My dog is acting aggressively," would naturally be followed by the statement, "Excuse me while I have a chat with him about this totally inappropriate choice!"

Actions can be changed, DNA cannot. If you believe your dog IS shy, scared, soft, aggressive, etc., you will become crippled in your training of him by his personality. However, if you believe your dog is acting in a certain way, you will treat him very differently because you will believe you can change his behavior.

Recently I was training with a friend. As I finished working one of my dogs, she commented, "He is so complicated." I thought about that for a moment. I had a choice. I could let her comment cripple me. I could believe that and start to doubt myself and my ability to deal with his "complicated" personality. "No," I told myself. I choose to disagree. He is not complicated, he is a dog and he exhibits normal "dog behavior."

Last summer at a seminar a woman raised her hand and asked if this philosophy worked with children. She continued that she had young twins, and that her son was outgoing but her daughter was shy and withdrawn. I have never claimed to know anything about children, but I asked her what she thought her daughter's reaction would be if she told her that she was not shy, that was not how her genetic code wired her to be. Instead, it was how she was choosing to act, and behavior is a choice. She told me she would give it a try.

Several months later we had occasion to chat again and she reported that her daughter was now approaching people, holding out her hand to shake theirs, and introducing herself by telling them her name and saying "I'm not shy!" What an enormous victory in a young person's life.

Have you ever said, "My dog shuts down"? Dogs don't shut down unless handler's let them. A dog's propensity to "shut down" is not part of his genetic code. It is a choice. It is simply a dog that believes that in response to being asked to do something, he has the choice to stop trying or to quit. If you say "My dog shuts down," you are rendered helpless and have to be very careful as somehow you feel responsible for causing this behavior. However, if you say "My dog is choosing to shut down (to quit)," you will realize that you have the ability to tell him that quitting is not an option.

What statements have you been making about your dog's behavior that you can change using this rule? This week, replace the verb "to be" with the verb "to act."
