

Brag from the UKC/CPE weekend:

Robert Q'd in 14 out of 15 agility runs with 14 first places. Such a good boy, although he was getting pretty hot and tired by the end. Rick was High Combined in rally on Friday, and then Bert taught me how to read signs, as I turned the wrong way on one in Rick's second run Saturday and flunked on probably his best run of the weekend. I was so busy telling Rick to BE QUIET that I turned the wrong way. Dah! But on Sunday I redeemed myself (and Rick agreed to go back in the ring with me), and Rick was High in Trial, High Combined, and High Cumulative Rally for the weekend.

My dogs had a <u>SUPER weekend</u> in July at the Central lowa Dachshund Club AKC obedience trials in Van Meter, Iowa.

Rick earned his 99th and 100th UDX legs to finish his UDX10 title. That means Rick has qualified 100 times in both Open B and Utility B at the same trial. An Amazing Feat! Rick is now retired from jumping 20 inches and will move on to the Pre/Preferred classes in Open and Utility where he can jump lower and not have to do stays.

Robert placed second both days in Open B and won Utility B on Sunday for 25 more OTCH points! He was also High Combined on Sunday, earning his fifth UDX leg. Robert now has 44 OTCH points and all of his first places for his AKC Obedience Championship. Former Member Passes

Carol Schwenneker was a friend and caring member of BDOC. Then she and Terry moved to Marion, Illinois. She died on July 1, 2015. She suffered a heart attack, aspirated, got pneumonia, and was not conscious after that. She was preceded in death by her father, mother on 1-14-2010 and Terry on about 2-4-2004. Also her beloved Afghans Gino, Danny, and Caleb. She is survived by a brother, Brian Hopkins of Seattle.

She left behind Diamond, an Afghan, and Selena, a Chihuahua, and arranged for the perfect people to take them into their care. Carol's internment was on July 12, at Calvary Cemetery in the mausoleum beside Terry.

I had just talked with her for about 1.5 hours two weeks before this. We reminisced about the time at AK SAR BEN. There was a livestock show but BDOC was inside to demonstrate the importance of picking the correct dog for your family and also taking obedience classes. We had a table to hand out pamphlets and answer questions. Then we performed obedience exercises.

Everyone put their dog on a down-stay dropped the leash and stepped about 5 feet in front of their dog I told Carol "not" to drop her leash. Gino was Gino. I was in the middle of a circle with Clever on a down-stay. I walked in and out around the people and dogs. Gino saw his chance for mischief. He got away from Carol and laid on top of Clever. Didn't hurt him at all but slowly you saw two grey paws and a head starting to stick out from under Gino's hair. I was looking the other way and didn't see it. Ron came into the ring and pulled Clever out and took him up into the Grandstand and gave him to Jeff to hold. Clever wasn't thrilled with big dogs after that.

Carol was almost completely deaf and blind but never let it get her down. I will miss her and so will many others. A very special woman.

This was my first time in 15 yrs. to go to a dog show circuit without a dog to show (since Gracie is too young and Rainy is retired). It was enlightening to just sit back and be a spectator. These are some of my thoughts and observations.

It takes humility to train and show a dog. Double dose if you show a Schnauzer <u>smile emoticon</u>. I could never have taken Mattie, my 1st obedience dog, to a UDX if I had depended on my own knowledge and ideas. I wondered why some find it easy to accept input and some do not. I realized that many years in recovery has taught me to trust those with more experience than I. It feels normal to me to try suggestions that don't make sense or seem like a good idea. I am grateful for that. It takes a village to train a dog.

To watch an upbeat happy team moving through the exercises is a beautiful thing. If the dog or handler makes a mistake and they are still moving through the exercises upbeat and happy, it's even more awesome. May I always remember that bad sportsmanship, aggressive body language, or making a scene doesn't belong at a show. It's ok to be disappointed. It's not ok to act out. I saw a few dogs work their hearts out but didn't Q, who's owners wouldn't even look at them exiting the ring. How sad. 2 years without a Q, Rainy has taught me it's just a dog show. We're not talking life or death here. Or as Lynn says, "If this isn't the right sport for you, there's always sky diving, one screw up and it's all over...."

People who come from a position of "How can I help?" "How can we better serve you?" "What do you need?" "What are your thoughts?" make fabulous obedience chairs!

It's my responsibility to manage my dogs stress at a show. It's not their job to manage mine.

A dog show is the whole show. Not just our time in the ring. What we do the rest of the time can make or break our runs. Marion taught me that. Thank you!

These I will add to the list of things I have already learned:

- 1. The dog isn't "doing it to me". They don't plot ways to embarrass me in the ring. They are dogs.
- 2. Mistakes made in training will double in the ring.
- 3. A 200 backyard run won't transfer to the ring. Dogs can't generalize.
- 4. Few problems can be fixed at a show. Thanks, Lynn!
- 5. More run throughs won't fix it either. Problems have to be taken apart and trained in tiny increments. Kind of like life.
- 6. My dog doesn't care if she wins. The ribbon means nothing to her unless she gets to shred it.
- 7. Not qualifying doesn't make me a bad person.

- 8. It doesn't make me a bad trainer either.
- 9. There is no way to proof for a squirrel falling out of a tree into the middle of an article pile.
- 10. There is no way to proof for a kid in a spaceship either.
- 11. At the end of the day I still have a great dog.
- 12. There's always another dog show.



The Reason for my Leash:

Your dog's social etiquette is none of my business, even if he is really friendly. If my dog is on leash, take the cue, and keep yours away.

There are many reasons for a leash. Mine might be injured, under the weather, having a really bad day, or simply enjoying nature with me and has no care whether yours is friendly or not. It might not be my dog, or it might be a brand-new dog that I don't know how he will behave. However, we are total strangers to each other, and other than a polite 'Hello,' I do not owe you an explanation. Simply take my cue of my dog being on a leash, and respect my space by keeping yours away.

If you feel yourself wanting to call out "He is Friendly" as you see your dog's bum galloping away from you towards an on-leash victim, counter your urge and instead be polite and call them back. *Monique Anstee*
