

Board Minutes October 7, 2025 The Zoom meeting was called to order by Gerianne Darnell, president at 7:11 pm. All board members were present.

Brain studies of dog responses to the scent of a familiar human (2015).

Rita had a great herding weekend at the BDOC AHBA and AKC herding trials in September. At the AHBA trials on Friday, Rita had a nice AHBA debut, starting out in Level III. She got three first places and a High in Trial with a score of 92, plus her first AHBA Championship point. In the AKC trials on Saturday and Sunday, Rita qualified 8 to 8 in her advanced classes with six First Places and two Second Places, two High in Trials, 1 Reserve High in Trial, and four AKC Herding Championship points. She also finished her Master Advanced A Duck title and her Master Advanced A Sheep title, each of which takes 11 qualfying scores.
